## **SINGAPORE WATERPOLO 14 & UNDER KNOCKOUT (Born 1993 or later) 2007**

### **MANAGEMENT**

1. The control and management of the competition shall be vested with the organising committee headed by the Tournament Director.

### **COMPETITION DATE**

2. The competition is **28 July 2007**.

### **ENTRY CLOSING DATE**

3. Closing date for entries: **6pm, Monday 9 July 2007**.

### **ELIGIBILITY**

4. Any player who is a member of a Singapore Swimming Association member/affiliate under 14 years old as of 1<sup>st</sup> January 07.

### **RULES AND REGULATIONS**

5. Unless expressly stated otherwise, FINA rules shall apply.

### **FORMAT OF COMPETITION**

6. A Knock Out System shall apply in this competition. Each team shall play at least two games. There shall be a Winner's Pool and a Consolation Pool.
7. In the event of less than 6 participating teams, round robin system shall prevail.
8. For all games, the duration of the game shall be as follows:
  - a. 2 halves of 5 minutes actual play.
  - b. If a draw occurs at the end of a game, the winner shall be decided by way of a penalty shoot out.

## **DRAW**

9. A draw to determine fixtures of the competition shall be conducted on 10 July 2007 at 0930hrs in Toa Payoh Swimming Complex.

## **WALK-OVER**

10. A team is deemed to have conceded a walkover if it is not ready to commence play after a 10-minute grace period from its scheduled play-off.

## **PENALTY**

11. Incomplete play. During the course of a match, if a team declines to continue play, it shall be deemed to have lost the match.

12. Turnout. Players shall not wear anything that is likely to cause injury, and shall not have grease, oil or any similar composition on the body. All players must wear trunks with separate drawers or slips underneath. A player infringing this regulation shall not be allowed to participate.

13. Discipline The following shall adjudicate on all disciplinary action regarding the competition (for e.g. misconduct by player)

- i.VP Water polo (or his representative)
- ii.Tournament Director
- iii.Commissioner of Referees

14. Protest. Any protest must be submitted to the game's Secretariat within 10 minutes from the end of a game. All protests shall be supported by the filling in the *Protest Form and the submission of \$100. This sum shall be forfeited if the protest is not upheld.* The following shall adjudicate on all protest(s).

- a. VP Water polo (or his representative)
- b. Tournament Director
- c. Commissioner of Referees

## **REFEREES AND OFFICIALS**

15. All referees and official will be designated by the appointed Chief Referee. He shall detail all officials after the tournament fixtures are determined.

## **ENTRY FEE**

16. An entry fee of one hundred and fifty dollars (S\$150.00) shall apply per team.

## **COMPETITION VENUE**

17. The Competition will be held at Toa Payoh Swimming Sports Complex, Diving Pool.
